Thank you for choosing LA Violin Shop (LAVS) for your rental needs. We have a 3-month minimum rental period required. After the initial 3-month period, we will automatically charge you by either credit card or ACH bank transfer. Monthly rentals with tax and insurance will be charged to your financial institution, unless you return the instrument back to our facility. You will be charged from the day your instrument leaves our shop until we receive it back in our shop.

- **Graduated Sizes and Instrument Choice:** Los Angeles Violin Shop offers a variety sizes. Customers get LAVS shop basic rental instruments.
- **Flexible Length of Term:** The minimum rental is 3 months. If you discontinue the rental and return the instrument, the last month's payment is the last charge you will incur.
- **Basic Rental:** Shop set up Carlos Rizzo Model Outfit (\$600 VN/ \$900 VA/ \$1500 CE)

Purchase Options

- 100% of the monthly rent is credited towards the Purchase up to 15 months for Basic Rental.
- Maximum 100% of monthly rental credits may be applied as credit towards up to 70% of LA Violin Shop's fair and honest tag price on any instrument (except Tax, Processing fee, Protection Plan, and Accessories rental).
- This discount (Purchase Option credit) must be applied towards purchase when returning instrument to LAVS; otherwise Rental Credit will be forfeited.
- If the renter missed payment or fail to maintain account current, the rental credit will be forfeited.
- Discounts are not held for future application, and are non-transferable. Conversion of a current rental account to purchase is NOT AUTOMATIC. Renter MUST ELECT to purchase.
- In the case of multiple rental instruments, individually accrued credit cannot be compounded towards the purchase of a single instrument.
- Rental credit applies solely towards an instrument purchase of the same type. For example, cello rental credit cannot be applied to a violin purchase.

Terms and Conditions

1. Instrument Maintenance and Coverage: LAVS commits to maintaining the covered instrument, bow, and/or case in excellent playing condition. In case of accidental damage, fire, or theft, LAVS will undertake repairs or replacements using items of comparable make, quality, and condition, in accordance with the provisions outlined in these Terms and Conditions.

2. Eligibility: Protection Plan coverage is applicable only to instruments, bows, and/or cases rented from LAVS. Accessory items and strings are not covered. Instruments, bows, and/or cases used for paid performances are not eligible for coverage. The Protection Plan is exclusively available to the original renters from LAVS and is non-transferable. Fees paid for the Protection Plan are non-refundable.

3. Customer Responsibility: Customers are responsible for presenting the instrument, bow, and/or case to LAVS at their own expense. This presentation should occur at LAVS's regular business location(s), either in person or through a common carrier, for required repairs or replacements.

4. Suspension and Reinstatement: If Rental Customers are more than 15 days overdue in their payments, the Protection Plan will be suspended. Reinstatement will be effective upon settling all overdue charges, including any additional Finance and/or Late Charges as stipulated in the customer's contract. During a suspension period, loss or accidental damage will not be covered. Repair or replacement costs will be the responsibility of the customer at the prevailing rates.

5. Liability Limitation: LAVS's liability shall not exceed the lesser of restoring the covered item to playing condition or providing a replacement. LAVS holds the sole authority to interpret the applicability of Protection Plan terms. The selection of repair, maintenance, or

replacement methods is solely at LAVS's discretion. The Protection Plan does not imply a cash settlement. LAVS reserves the right to cancel protection if a customer is found to be negligent or intentionally abusive. LAVS also reserves the right to pursue legal avenues to safeguard its ownership or security interest in the instrument, bow, and/or case, where applicable.

6. Liability for Cancellation or Damage: Exclusions from coverage include cosmetic damage that does not impact tone or playability, loss due to negligence, mysterious disappearance, unauthorized repair, arson, vandalism, or intentional abuse. Damage caused by third parties is not covered, and repair costs in such cases are the responsibility of the plan participant. Customers are held fully accountable for malfeasance, neglect, or loss. In the event of loss, a deductible of 50% of the retail price applies if customers provide proof. Otherwise, the full retail price is payable. Loss from school premises is not covered.

7. Proof of Loss: For theft or fire claims, proof of loss is mandatory. In case of theft, customers must report to law enforcement within 15 days and provide a copy of the police report. For fire, the remains of the instrument, bow, and/or case must be provided. A detailed, signed statement describing the loss circumstances is required for all claims.

8. Fee Structure:

- **Late Fee:** A late fee of \$9.00 will be charged if the automatic payment through ACH fails or if you neglect to update your credit card information prior to the payment due date.
- **Handling Fee for Outdated Information:** Customers who fail to maintain current credit card or checking account information will be subject to a \$25.00 handling fee.
- **Chargeback Fee:** A fee of \$35.00 will be levied in the event of a chargeback initiated by the renter while still in possession of the instrument(s).

9. Collection: Upon request, you are obligated to promptly return the instrument to LAVS. Failure to comply with this requirement will result in the obligation to pay the complete suggested retail price of the instrument, in addition to any outstanding balances. You hereby agree to cover all associated collection expenses, which may encompass but are not confined to, collection fees and legal fees. By entering into this agreement, you grant LAVS the right to access your personal credit report at any point during the course of this agreement. You also consent to allowing us, our representatives, and those to whom we delegate, including debt collection agencies, to communicate with you for the purpose of this agreement.

10. Termination: You hold the authority to terminate this agreement at any juncture, without incurring any penalties, by returning the instrument to us in sound condition. It is imperative that all originally provided accessories such as strings, bow, and case accompany the instrument upon return, or you will be liable to cover the cost of these items at the time of return. Please refrain from leaving the instrument at your school.
